YELLOWFIN FEVER

If you're a saltwater angler and fish the West Coast, no doubt you're already aware of the unprecedented action that the San Diego long range fleet has been experiencing this fall. Since October, records have been set, tackle has been broken, tales have been told—all as a result of an amazing volume of 200+-lb. yellowfin tuna caught on trip after trip, in waters about 700 miles south of the border, not too far off the Baja coast.

After viewing photo after photo of decks and docks stacked with piles of yellowfin ranging from 150 to more than 300 lbs., conservation minded anglers are beginning to ask questions. "Are we being piggy, and damaging the resource? Should we be releasing more of these trophy fish? How long can this go on?"

There are no simple answers to these questions, but they need to be asked. Responsible anglers ought to be concerned about the overall health of the fishery—particularly in light of all the gloom and doom news that we see in the popular press about the depletion of the world's tuna stocks. Here's the good news. The yellowfin tuna stocks in the eastern Pacific Ocean are quite robust and it appears they are being fished at sustainable levels. The Inter-American Tropical Tuna Commission (IATTC), established by international convention in 1950, is responsible for the conservation and management of fisheries for tunas and other species taken by tuna fishing vessels in the Pacific. A visit to the IATTC website will confirm that our yellowfin tuna stocks are enjoying a robust abundance compared to other tuna species and other parts of the

world.

To determine the best course of action I sought out **Kurt M. Schaefer**, a senior research scientist with IACTTC. His research has focused on the life history and characteristics, life cycles of tuna populations throughout the Pacific. Kurt has been engaged in this activity for 30 years and has recently taken charge of a number of tagging programs. A long range boat, the *Royal Star*, will visit the Revilla Gigedo for a tag and release expedition. Departing from San Diego on Feb. 15th 18 anglers will pay \$5500 to be on the trip. \$4000 is for the trip and \$1500 a contribution to purchase archival tags.

Questions asked of Kurt Schaefer:

How long do Yellowfin live? *They are the fastest growing fish in the ocean, but a really old one may be no more than about 9 or 10 years old. This is unusual. On average they live about 5 years.*

Are the really big ones mostly males? *Yes, It is safe to say that virtually all YFT from about 250-400 are males. Calling them "cows" is somewhat of a misnomer.*

Is it true the largest ones starve to death? *Absolutely not. They died of old age and age related diseases. A YFT can go several weeks without feeding, if need be.*

Are the largest more likely to die after release? *Unless they die of a heart attack before reaching the boat, all tuna are very sturdy and survive well upon release, regardless of size. As long as they are able to swim away they will probably survive.*

Westcoast albacore fishermen were mostly idle in July & August thanks to high fuel costs and cold weather. Finding albacore 100-plus miles out used up lots of fuel at (\$2.60 per gal.) which the smaller boats could not afford. Fishermen were getting \$1.25 to \$1.50 a pound from buyers. ■

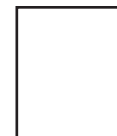
