

### **EDITORIAL** by Dan Felger

The majority of LARRC members are aware that the Mexican government has revoked all permits to fish the Revillagigedos Islands. This includes all sportfishing boats, yachts, and commercial vessels. Unfortunately, the permits were revoked with short notice and during the middle of the current season. This forced previously scheduled longrange trips to either cancel or travel the additional distance to Clipperton Atoll. The reasons for the closures are somewhat vague, but basically have to do with the Mexican Government's conception that the fish stock at the Revillagigedos is being depleted. At the present time there is no scientific evidence that would either prove or disapprove this contention. Seven years ago a plan for the management of the Revillagigedos was to have been prepared. This has not been done, and it is not certain if, or when, it will be prepared. In the meantime the impact of the closure is very significant. It is my personal belief that sportfishing has a minimal effect on the tuna stock. One seiner can take in a single set what ALL sport fishermen combined will take on rod & reel over a period of years. Although the islands have been closed to commercial fishing for years, commercials still poach. The Mexican Navy will not be able to patrol the island chain on a regular basis, and without the presence of the sportfishing fleet there is no one to blow the whistle on the poachers.

At this time there is no timetable for

The 2002 Foundation Trustees consist of Larry Brown, Michael Godfrey, Michael Grossman, Al Spievak, Pamela Warren, Norm Weinstock and Randy Sharon. The Foundation was formed in 1951 and since its' formation, the primary purposes have been to introduce underprivileged kids to fishing and the conservation of our ocean environment.

2002 marks the 53rd anniversary of the LARRC Kids'Trip. The Foundation strongly encourages everyone to participate in this wonderful event. This year's trip will take place on boats fishing out of Pierpont Landing in Long Beach on July 8th, and we expect to take almost 500 kids fishing. **Jim Port** will be the chairman of the event. If you have any questions concerning the Kids'Trip, and would like to help out, please contact Jim.

The trustees of the Foundation have two general goals: (I) to raise as much money for the Foundation as possible; and (II) to use the money best suited for the Foundation. Some of the items discussed at the last Foundation meeting included the following:

- Thanks to the efforts of many club members, the Foundation received over \$13,000 from the 2002 auction held in conjunction with our annual awards banquet earlier this year.
- The trustees agreed that the 2003 auction will also be held at the next banquet in 2003. (February 22, 2003). The trustees also agreed to act on the recommendation by Paula Grossman to have more items for the ladies.
- · Additionally, the Foundation will gladly (and gratefully) accept all kinds of donations, including used cars and boats.
  - · On August 7, 2002, the Foundation

will again sponsor our "Marine Mentor's Trip". The Marine Mentors trip will be held on the *Spitfire* out of Marina Del Rey. We will have one member of our club assigned to each of the kids to help their fishing efforts and to assure they will have a wonderful day on the water.

- Last year, the Foundation granted \$3000 to the Cabrillo Marine Aquarium. This money allowed approximately 525 economically disadvantaged kids to participate in the scholastic Sea Search program provided by the Cabrillo Aquarium. This year the Foundation granted another \$5000 for similar purposes.
- The Foundation is looking into the establishment of a program with Los Angeles schools and other groups for the purposes of taking disadvantages kids fishing.

The Foundation holds quarterly meetings. We are scheduled to meet on August 12th and December 9th of this year. All members of the LARRC are welcome to attend and participate.

If any of you have any ideas on how to generate money, or how to use the money, please give any of the trustees a call, or better yet, attend the next meeting and share your thoughts.

ust about everybody is familiar with the bizarre antics of Tradical groups like People for the Ethical Treatment of Animals. PETA's agenda is simple but devastating in its consequence: Stop all fishing, outlaw dogs and cats as family pets and strip the evil human population of all leather goods. While PETA has gained notoriety for its movement, other groups with equally radical agendas are moving in a quieter and more effective manner to accomplish goals that, while somewhat different, are equally at odds with truth or reason. Right now, extremist environmental groups are waging a subtle battle in California and other states for the public's premier coast recreational areas. Within the past year, schemes have been hatched that would SHUT DOWN more than 60 percent of Southern California's best sportfishing grounds.

This anti-fishing campaign didn't start in California, and it won't end there. Already, no-fishing proposals have circulated throughout New England, Florida and other parts of the Southeast. It's just a matter of time before these well-organized and and richly financed groups tell you that you're no longer welcome in your public waters. These groups, in an ever-expanding campaign to increase membership and advance the misguided agenda, have said to heck with America's 12 million saltwater anglers (not to mention the rest of the public). The Ocean Conservancy, for one, proclaims that large swaths of ocean should be

turned into "ocean wilderness areas" where no one but a privileged few should tread.

There's nothing wrong with the concept of protecting ocean areas, but they should be modeled after our terrestrial system of national parks where public recreation is allowed, but commercial exploitation is not. Some of the nation's best freshwater fishing occurs in our national parks, wildlife refuges and national forests. We all want our oceans teeming with fish. They say the best way to do that is to keep you, the public, out. They ignore the effectiveness of proven conservation tools like bag limits, size limits and seasonal restrictions tools that have returned abundant striped bass, redfish and white seabass to our coasts. They also fail to appreciate the fundamental difference between a family fishing on a Saturday afternoon and a factory trawler indiscriminately dragging the seafloor for months on end.


The groups pushing to ban recreational fishing along the thousands of miles of our nation's coasts will succeed with radical agendas — UNLESS WE UNITE. Every real conservationist, whether you are a recreational fisherman or not, needs to get



involved. You're not going to convince the radical elements to change their ways. They're organized, they have money and they have an agenda. However, these groups can't keep out the public on their own. They need to get key policy makers to implement their agenda. You can stop these groups from having their way by making sure that your elected officials and your state's fish and game department hear your VOICE. As a first step, go to www.freedomtofish.org and tell them that you will not be kept out by narrow-minded environmental extremists.

Tell them to protect the fish and your freedom to fish!.

# HEALTH ADVISORY... Pete Giannini Reports!

n 2000 I was fortunate to catch my "fish of a lifetime" which was a 242-lb. yellowfin tuna off Clarion Island. This last year on the September club trip of we ran into great yellowfin tuna fishing off Guadalupe Island. I succeeded in landing over 450 lbs. of YFT. This year, as I draft this article, I am sitting here with a large hole in my right nostril from a malignant melanoma.

Fishing, to me, is the greatest sport in the world. I have fished for all types of fish ever since I was a boy catching catfish on the Kings River south of

Fresno. I wish I had paid a lot more attention to the health hazard posed by excessive exposure to the sun. I am presenting this article in hopes that my fellow fishermen will be much more careful than I have been.

Fortunately, the melanoma had not penetrated deeply, nevertheless several

reconstructive surgeries are indicated. So the caution flag should be out and I urge all members to be extremely careful with respect to their sun exposure. Special hats and shirts, and other clothing can be obtained from Solumbra at 1601 Montana Avenue, Santa Monica, CA 90403. Phone 310 451-5858 or try their web site **www.sunprecautions.com**. In addition, I urge the use of the most powerful sun blocking salve that can be obtained for additional sun protection.

It is my opinion that ultraviolet exposure is not only heavy during the peak hours of the day but, that in the earlier, as well as later hours, reflection of the sun off the ocean onto a persons' face and arms can be devastating. I urge my fellow club members to enjoy their fishing but also take appropriate precautions.



#### **Largest Marlin Ever Taken on Fly**

Tom Evans, a Vermont angler was looking for a challenge. Having caught five world record tarpon (over 150 lbs) he wanted a fly rod billfish which would beat the current record — a 1995 Costa Rica striper. Fishing off Australia's New South Wales coast, he first scored a 230.8-lb. fish. This would beat the existing record

by 50 lbs. if approved by the IGFA. However, on March 2nd, his last day of fishing, he landed a Pacific Blue Marlin of 288.7 lbs on 20 lb tippet which would be the largest fish ever taken on fly.
