## Impact of Recreational Fishing

The L.A. Times recently reported on a study, conducted every five years, by the Census Bureau and the U.S. Fish and Wildlife Service. This study was given wide distribution by the ASA (American Sportfishing Association) and many in the media picked it up. The results might be expected but here it is in black and white:

Fishing remains the most important popular outdoor activity in the U.S. Its

huge ripple effect on the economy is virtually at all levels. Anglers contributed expenditures related to fishing—valued at \$42 billion. Additionally the broad economic values were estimated at \$116 billion for 2001. Sportfishing also supports more than one million jobs.

Now if we could only organize this massive resource as one potent voice. ■

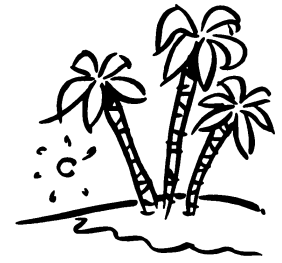

# LARRC Honored at Cabrillo Marine Aquarium

The Grunion were running Friday night April 4, and the Cabrillo Marine Aquarium used the occasion to thank and honor their corporate and foundation sponsors with a special Meet the Grunion Evening. Foundation President **Randy Sharon** and **Helayne** and the kids, and Trustees **Mike Godfrey** and **Larry Brown** with their wives **Nickie** and **Marie** represented LARRC at this family and festive event.

All of the aquarium's fabulous exhibits were open. There was a great 15-minute video on the life cycle and sex life of the grunion. Hundreds of jars containing Grunion eggs were passed out and when technicians circulated with fresh sea water we all agitated the eggs, simulating a high tide, and watched with amazement the instantaneous live birth of hundreds of grunion. It was truly amazing—the miracle of life. Refreshments were served and then we all walked to the beach and waited for the grunion. Those who were able to brave the wind and cold were rewarded by millions of grunion riding the rising tide to perform their mystery mating ritual. The females burrow tail first into the soft wet sand and deposit their eggs, while the males fight to wrap around their chosen mate and deposit their sperm into the sand and fertilize the eggs. The eggs will hatch with the next rising tide sending billions of grunion out into the harsh sea.

The Cabrillo Marine Aquarium is a fantastic marine facility and the largest marine education aquarium in the word. They have wonderful exhibits and great education programs. The

I've also worked on sportboats and managed a landing. Unable to satiate the need to fish, on occasion I've been known to take off on commercial fishing ventures. I've worked bonita and thresher sharks, the live fish markets,

*Boarding time:* 8:00 p.m.

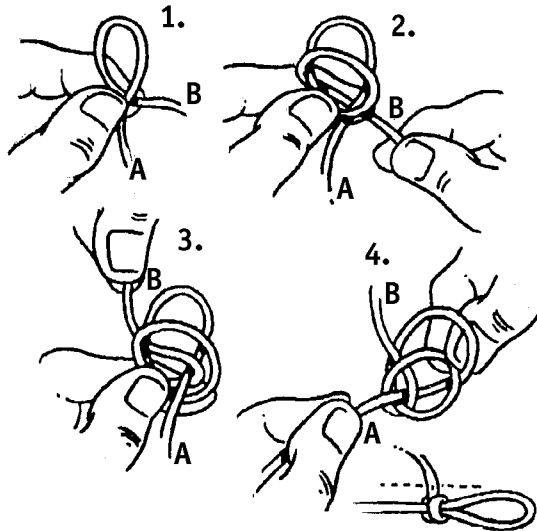
**SAN DIEGO** *Departure Time:* 11:00 p.m. (Saturday)

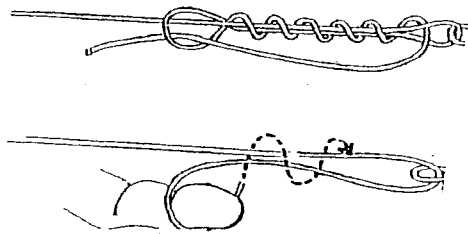
## The Perfection Loop



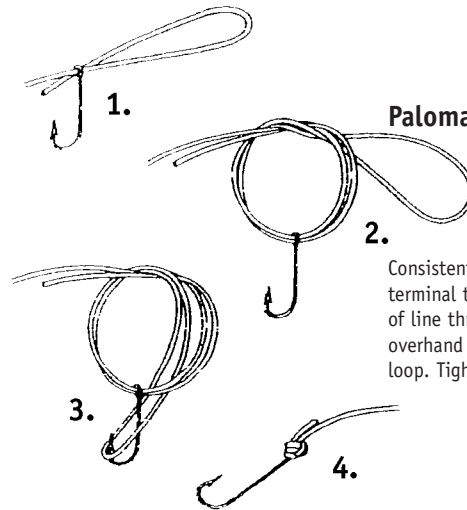
The perfection loop is a solid loop knot that does not slip. This knot is used by many anglers to give both bait and lures a natural look of movement from side to side.

1. To begin the knot make a loop, as shown in FIG.1, and hold the loop with your thumb and index finger.
2. While holding the loop, wrap line "B" around your thumb and the loop and hold as in FIG. 2.
3. Make additional wrap using line "B" and hold both wraps as shown in FIG. 3.
4. As shown in FIG. 4, grasp the first wrap with your thumb and index finger and pull it through the original loop. Holding the line "B" loop, seat the knot by pulling the line "B" loop and line "A" in the opposite direction.

## San Diego Jam Knot

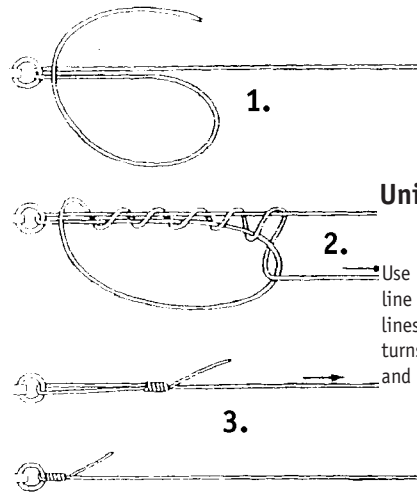


1. Run six inches of line through the eye of the hook or swivel and fold it back to make two parallel lines.
2. Holding both lines in your right hand, wrap the tag end around your finger, as shown above. Bring the tag back towards the eye using five or six spiral wraps around the two parallel lines. Pass the tag through the loop above the hook and then back through the loop caused by your finger. Pull the tag and standing lines together forming the knot above the hook. Wet the knot and carefully draw it down until it touches the hook.
3. Using double lines to tie the above knot can improve the breaking strength to upwards of 95 to 100 percent.



## Palomar Knot

Consistently the strongest knot to hold terminal tackle. Double about 4 inches of line through eye of hook. Tie an overhand and then slip hook through loop. Tighten and clip closely.



## Uni Knot

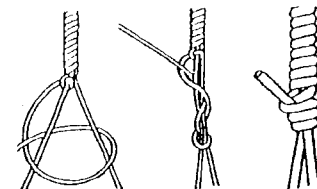
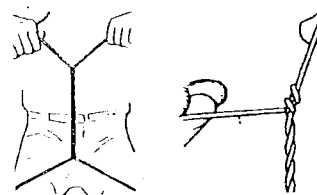
Use with lure, hook or swivel. Run 6" line and fold to make two parallel lines. Bring end through and make six turns. Snug knot and slide knot to eye and trim.

## Bimini Twist

These directions apply to tying double lines of around five feet or less. For longer double-line sections, two people may be required to hold the line and make initial twists

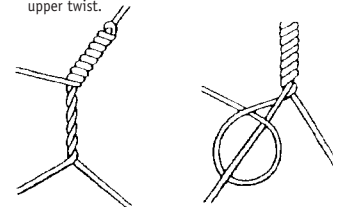


1. Measure a little more than twice the footage you'll want for the double line. Bring end back to standing line and hold together. Rotate end of loop 20 times putting twists in it.



With half-hitch holding knot, release knee pressure to keep loop stretched out tight. Using remaining tag, take half-hitch around both legs of loop, but do not pull tight. Make two more turns with the tag end around both ends of the loop, winding inside the bend of line formed by the loose half-hitch and toward the main knot. Pull tag end slowly, forcing the three loops to gather in a spiral.

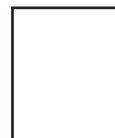
2. Spread loop to force twists together about 10" below tag end. Step both feet through loop and bring it up around knees so pressure can be placed on column of twists by spreading knees apart.
3. With twists forced tightly together, hold standing line in one hand with tension just slightly off the vertical position. With other hand, move tag end to position at right angle to twists. Keeping tension on loop with knees, gradually ease tension of tag end so it will roll over the column of twists, beginning just below the upper twist.



4. Spread legs apart slowly to maintain pressure on loop. Steer tag end into a tight spiral coil as it continues to roll over twisted line.
5. When spiral of tag end has rolled over column of twists, continue keeping knee pressure on loop and move hand which has held standing line down to grasp knot. Place finger in crotch of line where loop joins knot to prevent slippage of last turn. Take half-hitch with tag end around nearest leg of loop and pull up tight.
